By signing this document, I agree to the following Attendance Guidelines for the live event on July 7th, 2020:

1. Wearing masks is mandatory to cover mouth and nose throughout the evening unless otherwise instructed.
2. Keep the required minimum distance of 2,00 meters AT ALL TIMES.
3. Use the on-site disinfectant stations during check-in and wash your hands after bathroom breaks.
4. If you are intoxicated, entry will be denied.
5. During the event please stay in your assigned circles at all times until told otherwise.
6. Should you need to leave your circle (e.g. to use the restrooms) notify the staff by raising your hand.
7. Restrooms are only to be used by one person at a time.
8. Do not bring any other liquids apart from water. We will provide drinks.
9. Smoking at the premises is prohibited for the whole duration of the event.
10. If you should be held responsible for any damages to equipment or the sports ground, you will have to compensate the damages.
11. If you drop a bottle and it results in shards, tell the staff immediately so they can be removed from the grass.
12. No littering. Use the bag provided at check-in. Do not take any empty bottles home with you.
13. Participation in the event, as well as arrival and departure, will be at your own risk. We will provide all necessary steps to make sure our Corona Hygiene and safety concept designed for this event will be followed.
